Supervisor Jeff Propps advised residents that as of today FEMA announced that York County will be approved for public assistance due to damages from Tropical Storm Lee.

She said that normally the insurance company is supposed to contact the municipality, but if the township does not hear from them, they should send a letter to the homeowner about the ordinance.
